Resolution Supporting the Anchorage Water and Wastewater Utilities (AWWU) 880 Reservoir Site Selection

WHEREAS, AWWU has established a community member working group to study the need and sites locations for the 880 Reservoir Site; and,

WHEREAS AWWU has presented to the members of the ERVCC on multiple occasions; and,

WHEREAS, AWWU held a local community meeting at Ravenwood Elementary School on November 16, 2016; and,

WHEREAS the Community Council membership has now had the opportunity to review the HDR/RPKA 880 Reservoir Site Selection Report; and;

WHEREAS the HDR/RPKA 880 Reservoir Site Selection Report recommends a minimum of 5.37 acres for the preferred "Stewart Parcel" location "justified by the steep topography of the region, as well as providing adequate space for vegetative screening buffers";

THEREFORE, BE IT RESOLVED THAT the Eagle River Valley Community Council hereby submits the following feedback and recommendations;

- There is general acceptance of the membership that there is a need to add a water storage;
- 2) There is general acceptance of the need to add a Water Reservoir to the Eagle River Distribution System at the 880 elevation as described by AWWU;
- 3) There is general acceptance of the engineering analysis; and support for the preferred location of the "Stewart Parcel", as long as the recommendation of 5.37 acres (or more) being purchased is accomplished; and,
- 4) BE IT FURTHER RESOLVED that the ERVCC membership requests further involvement and input in the final design analyses and preparation so that local community concerns can be accommodated.

WHEREAS the CCC has requested a resolution from the ERVCC in support of the rural nature of Eagle River and the desire of the residents for low density housing options;

THEREFORE, BE IT RESOLVED THAT the Eagle River Valley Community Council hereby declares unconditional support and backing of the Chugiak Community Council Resolution 2016-6, and;

BE IT FURTHER RESOLVED that the ERVCC membership requests no changes to the Carol Creek Area Plan without a fully noticed public review of proposed changes to housing densities.

Resolution Requesting Mayor Berkowitz to Consider a bus (transportation) plan which includes bus service to Eagle River

WHEREAS, the ERVCC membership has reviewed and discussed the issues regarding the need for adequate bus service to and from Eagle River and Chuqiak; and.

WHEREAS community members presented to the members of the ERVCC on the recent people mover decision to employ 12 passenger vans on the Eagle River routes; and,

WHEREAS, members of the bus riding community present noted that at least 13 - 18 people ride on people mover buses in the AM, which would present a shortage of seats with the current plan, with over an hour wait for the van to return; and,

WHEREAS the Eagle River / Chugiak bus routes have already been significantly curtailed over the last few years; and,

WHEREAS, the Eagle River / Chugiak area residents also pay their share of taxes and fees to the Municipality;

THEREFORE, BE IT RESOLVED THAT the Eagle River Valley Community Council hereby declares it is opposed to the current proposed mass transit plans, because they all exclude and do not provide for the transportation needs of the Eagle River / Chugiak area residents; and,

BE IT FURTHER RESOLVED that the ERVCC membership requests that Mayor Berkowitz request and consider a new plan which would provide equipment for equal services for the Eagle River / Chugiak areas.
