

This letter is to speak to the ways in which Buck Walsky of Walsky Construction is an asset to the Anchorage community.

MEMORANDUM AGREEMENT

BETWEEN

GOVERNMENT HILL COMMUNITY COUNCIL

AND JEONGSU YUK

PURPOSE:

A Community Plan has been created for all liquor stores that operate in Government Hill. This community plan will be incorporated into its Conditional Use Permit.

This Community Plan is specifically for the liquor store that is located at 867 E Loop Road. New store owner is Jeongsu Yuk.

RESTRICTIONS OF SALE:

- 1. No fortified wines less than \$10.00 a bottle.
- 2. No six packs of beer less than \$6.00.
- 3. No restrictions on liquor products that less than 750 milliliters.*

*If Government Hill experiences issues with liquor bottles found in the Government Hill parks and residential areas and if there is an increased issue with vagrants and/or homeless population in the residential area and/or parks, sale of liquor products less than 750 milliliters will be discontinued permanently. Steps for discontinuation will be the following: Notification to Owner, Notification to CHARR; Notification to the State of Alaska Alcohol & Marijuana Control Office, and Notification to the Municipality of Anchorage's Assembly. Owner will be required to remove all liquor products from store that are less than 750 milliliters within 30 days of notice.

- 4. Licensee shall place a sticker or other identifying mark on all products sold as individual containers.
- 5. Licensee shall not sell alcohol after midnight.

STAFFING REQUIRED:

1. TAMS or equivalent training shall be provided to all store personnel within seven calendar days of hiring.

ADVERTISING RESTRICTIONS:

1. No promotional price signs in the windows (neon excluded). No low price newspaper advertising.

MEMORANDUM AGREEMENT

COMMUNITY REVIEW REQUIREMENTS:

- 1. Semi-annual review of operations by the Government Hill Community Council, if desired by the Government Hill Community Council.
- 2. Video tapes of customers viewable on request, through Municipal authorities, by the Government Hill Community Council held for a period of five days.

OTHER CONDITIONS:

- 1. A copy of the conditions imposed by the Assembly in connection with this conditional use approval shall be maintained on the premises and at a location visible to the public.
- 2. Licensee shall require all customers to show a valid, official state identification card, passport of military identification card as a condition of selling any alcoholic beverage to that customer.
