**Call to Order**: by Vice-Chairman Kim MacBeath at 6:06 PM.

**Agenda**: Approved with the addition of Save the 4<sup>th</sup> Avenue Theater under New Business.

**Approval of Minutes**: February minutes were approved with one correction.

### **Anchorage Police Department** – Sgt Cindi Stanton

Please give her notice of hot issues so she can be sure to attend the council meeting. On some nights there are so many meetings she cannot attend all of them, so she has to prioritize.

Bob Ruepke asked what the police academy schedule was? The present academy still has 24 cadets. The next academy will convene this summer.

Lance Powell asked what would be the impact of allowing Municipal employees to write citations? The requirement to have a sworn officer means that citation writers have to have completed the academy, which raises the pay granted the employee (right now that is only Community Service Officers). Also, this would free up police officers to respond to crimes.

#### Mayor's Office – Teri Albrecht

She met with developer Lee Baker over issues from the councils.

- Eagle River landscaping will be provided
- Scenic Foothills the drain pipe will be replaced with a larger one
- University contractors will work with the Castle family and neighborhood

The CIP is still being managed by the Office of Budget (Bruce Holmes).

Bill Gossweiler asked if there will be a vegetative screen shielding the view of the highway? No, but the neighbors will be able to use his connection to hook up with AWWU.

Robert Hayes asked if there are plans to cage the dog parks. Diane Etter replied that there is some money for this in the parks plan, though fencing at University Lake will have to wait until the master plan for University is complete.

#### **Anchorage School District** – Jeff Friedman

Not present, but he submitted a written statement that was distributed to everyone.

### **Anchorage Assembly** – Janice Shamberg

- Assembly granted \$108,000 to the FCC. The vote was 8-0 (Paul Bauer abstained because he declared a conflict of interest).
- To encourage developers to work with communities and the MOA, P&Z is now allowed to work concurrently on zone changes and permits.
- Money is available for fish restoration in Campbell, Chester and Ship Creeks.
- Fairview Community Council is approved for developing a neighborhood plan.

Hank Hosford asked if the money is restricted to those creeks? No, it is for any creek with a history of fish. Bill Gossweiler noted that Eagle River has a small red salmon run.

Cathy Gleason asked if this included Westchester Lagoon and was the Assembly aware of the complications for the fish ladder? Westchester Lagoon is first on the list.

Bob Ruepke asked what was happening with the Billik Inn? The liquor license and inventory were bought by Dan Sullivan for the Irish pub he is developing next to City Hall.

Mike Gutierrez asked what was the status of compliance for Fantasies on 5<sup>th</sup> Avenue? Assembly approved the liquor conditional use permit based on apparent compliance.

Ed Leach asked if the Municipal Clerk could post ordinances on the Internet when they are submitted? Not being done due to a shortage of staff.

### Sullivan Arena Waterline Upgrades – Tom Winkler (AWWU) and Julie Jessen (HDR)

- Eleven water line failures in the past three years. The east water line was installed in 1994, but is experiencing early failure. Apparently the high ground water table is promoting a chemically active soil that is corrosive to the iron water pipes.
- The iron pipes will be replaced with HDPE (high density polyethylene). HDPE is used extensively in Bush Alaska, so it will not crack in the cold. Metal valves and hydrants will have an epoxy coating and sacrificial anodes.
- Construction will begin May 15 and complete August 15. Construction will be suspended during major events. The construction will be sequenced in seven segments to minimize interruptions in the area.

Cathy Gleason asked if there would be tree removals in the Chester Creek Greenbelt? Yes. Cathy then opined that the trees should be replaced.

# Save the 4<sup>th</sup> Avenue Theater – Jane Angvik

- Proposition 6 on the ballot is to borrow up to two million dollars to match private funds. If the private monies are not adequate, the bonds will not be issued.
- The theater is the only art deco building of its kind in Alaska.
- If approved, the bond will cost \$0.65 per 100K of valuation.

Bill Gossweiler asked if the private financing plans included private ownership shares? Various financing schemes are being evaluated for raising the money.

Mike Gutierrez asked why Anchorage Historic Properties is not going to be the manager for the theater? This has not been decided and AHP is one of the participants in the planning.

Bob Ruepke asked if an appraisal was done? Still in progress.

Robert Hayes asked if any code upgrades will be required? The building meets all codes, though they are still deciding what the uses will be and the remodeling required for those uses.

**Treasurer's Report** – accepted as submitted.

### **Community Councils Center** – Ed Leach

- Urged the delegates to have their councils use the website to publish information to their members. He recommended that people view the Fairview and Russian Jack pages for ideas of what can be done.
- Noted that the Center is trying not to send large attachments (over 200 KB). He requested that councils tell others to link to web pages in place of sending large emails. The CCC will construct web pages if necessary.
