AGENDA FOR JUNE 15th, 2004

Agenda for the June meeting will include AWWU water tower rezone; Short Plat/Abbreviated Plat ordinance; a proposed platting in Gregory Subdivision (Case No. S11276, subdividing two tracts into 13 lots and three tracts with a variance for cul-de-sac length); Hillside District Plan update; Lake Otis Gravel Pit & Pit To Park update; Fire mitigation funds; Site Plan Review/Public Hearing process; and an update from AMATS meeting regarding DeArmoun Phase I.

In addition to the main items on the agenda, our current list of continuing business that we are tracking, and update every month, includes the Assisted Living Ordinance; Road upgrades (Elmore, DeArmoun Phases 1 & 2, Huffman, O'Malley and various RAP (recycled asphalt) projects in the area); large animal facility ordinance; SAHS opening this fall; and the Mona St. rezone.

HERITAGE LAND BANK

We have received notice of a public hearing on July 20, 2004 at 11:30 a.m., at City Hall, Room #525 regarding a Resolution of the Heritage Land Bank (HLB) Advisory Commission recommending Assembly approval for revising the Anchorage Municipal Code to change HLB into a Development Authority Agency.

AWWU WATER TOWER REZONE

A section of property adjacent to the South Anchorage High School property is going to be rezoned to PLI in accordance with a Municipal requirement. We will discuss this upcoming case thoroughly at the next meeting.

ELMORE ROAD UPDATE

Elmore road is about 90% completed as of July 8th. The following items still need to be completed before the anticipated August 1st completion date: installation of the round-a-bout (internal curbing, decorative concert slab, center piece planted with birch trees); complete the application of topsoil, tree plantings and hydro seeding; final layer of asphalt; road stripping; gate installation on Leyden (west side of Elmore), Kutcher and Doroshin; street lighting fixtures (heads and bulbs), and regulatory traffic signing.

GREGORY SUBDIVISION PLATTING

A site plan review application has been received for the property adjoining Bowman Elementary to the south. The developer would like to plat this ten acres into cluster housing. We have serious initial concerns regarding traffic because of the already problematic traffic associated with the elementary school.

If you live in this area, please come to the meeting to let us know your concerns. This case is currently scheduled to be decided on August 4th and we need to get our comments in.

CANDIDATE'S FORUM

The Huffman/O'Malley Council has joined with Abbott Loop, Bear Valley, Basher, Glen Alps, Hillside-East, Mid-Hillside, Rabbit Creek, and HALO (Home and Landowners Organization, Inc.) to sponsor a candidates' forum on Thursday October 7 at O'Malley's On The Green, from 7-10 p.m. Just giving advance notice so you can put it on your calendars.

TITLE 21 REWRITE
