  - b. For several years ASD schools have not been at capacity
  - c. What did ASD do with Covid funds? They are limited in what they can be used for.
  - d. ASD is projected to lose 5000 more students in the next 5 years, what long term planning are they going to do to prevent waste of funds?

- e. Rachel states she asked ASD for accounting all last year. Why do they seem to prefer deferred maintenance vs preventative?
- f. Why do Anchorage students get 0.8 BSA vs the Valley students who get 1?
