Bayshore-Klatt Community Council Housing and Homelessness Survey

Anchorage assembly members on the Housing and Homelessness Committee (H&HC) requested that the Bayshore/ Klatt Community Council (BKCC) join ten other community councils from Hillside/O'Malley and Oceanview to Girdwood and Turnagain Arm to determine preferred locations for potential homeless shelters. This group is the South Anchorage District (SA District) and together we are preparing feedback for the Assembly as to where to put a "Low or High barrier shelter" in our District according to the "Clean Slate Strategy."

Definitions:

Low Barrier Shelter: A location that has minimal requirements and expectations for entry.

High Barrier Shelter: A location that places requirements on guests, such as sobriety, curfews, church attendance, program participation, identification.

The H&HC held a series of Townhall meetings, June 3, 4, & 5 to obtain public input. Felix Rivera cancelled all August 2023 meetings of the Housing & Homelessness Committee.
