Anchorage Assembly Report – Scott Myers

- Welcome to Mark Littlefield as our new representative.
- At this week's Assembly meeting there was a comment about using Mac Center as a homeless shelter. However, this location does not meet criteria to be used for that purpose (lack of public transport, etc.)
- It appears likely the public restroom and cemetery bonds failed. Representative Allard is pursuing alternatives for the cemetery.
- There was lengthy discussion at Assembly meeting on Eklutna Hydro Project.
- Mayor's vetoes were overturned by Assembly.
- Upcoming topics many departments are hiring. Boards and Commissions volunteer approvals are being "held" until mayoral election is completed. Eagle River is under-represented so consider applying for a position.
- What are our council's priorities for capital improvement projects?

## **Anchorage Fire Department**

- Seventeen (17) new employees are attending academy and will be on line in June. All are replacing retirees. One hundred (100) are eligible to retire in next two years. It takes 6-12 months to replace someone. Have total of 350 line personnel.
- See the "current wildfire map" on muni.org website under Fire Dept. Sign up for emergency alerts here, too.
- Firewise inspections are available by Fire Dept personnel to provide advice on your property.
- Contact the Burn Hotline to learn rules and dates for open burning.
- Check your smoke alarms to be sure batteries are fresh and alarms are working properly.

## **School Board Report –** Andy Holleman – written report

- We are moving ahead with our amended budget, counting on about \$100 increase in the Base Student Allocation. This much was added to the original budget for next school year when the House and Senate passed a bill adding \$680 to the BSA. Any increase is uncertain at the time.
- Principals have received their FTE (Full Time Equivalency) numbers for staffing this fall. Reductions are being
  made around the district, including administrative posts. If there is no increase in funding at the end of the
  session, there will be additional cuts, at a difficult time of year. Our hope is to avoid dismantling programs now,
  as we're not able to walk back staffing changes, which are being made now, if funding comes later.
- We're moving into a time of graduation and crossing-over ceremonies all around the district.
- We are on budget to finish out this school year.

Ram Valley Access project

- Chugach State Park Advisory Board needs more representation from Eagle River. Consider volunteering. See application link at bottom: <a href="https://dnr.alaska.gov/parks/misc/chugachadviseboard.htm">https://dnr.alaska.gov/parks/misc/chugachadviseboard.htm</a>
- Ram Valley lost "public access" in 2019 when access over private property was withdrawn.
- 2024 Alaska Legislature approved funding to investigate possibility of public access to Ram Valley. Alaska Trails is spearheading this investigation and will report back to Chugach State Park.
- Have 5 potential access sites under investigation
  - Need publicly platted road.
  - o Identify needs to acquire new real estate.
  - O What are potential costs?
  - o Parking lot potential?
- There is no legally mandated process to solicit public input.

## Comments and questions included:

- Will this be year-round access? Only 1 trail in Park is officially winter access now but anticipate year-round use.
- Will police coverage be increased? Troopers patrol state land. Chugach rangers are trained officers. Municipal troopers cover trailheads. This is outside scope of current effort which covers access plans only.
- Timeline? 5-year timeline to look at access. Current 5-year grant for access investigation ends in 2029. If additional funding is obtained, there will be another 5-year plan.
- Why Ram Valley now? Has been on park plans for many years.
- Type of trail and visual impact? Currently looking at Class 2 trail- must be hand built, single track (1 person).
- Wildlife? Area with rams, grizzlies, moose and avalanche danger.
- Any projections on volume of future use? No information is available. We only have phone survey data on current
  use.
