Can Roads and Drainage Support Dense Developments in Rabbit Creek?

As residential growth in the Rabbit Creek Council area continues, the traffic congestion and drainage issues create an immediate need for two collector roads and drainage studies before any further development continues. Since we are outside the Anchorage Road Service Area, we must look to the State Legislature for road funding.

In April, Lori Davey, (South Goldenview Limited Road Service Area Chair) and Susanne Comellas (past RCCC Board chair), traveled to Juneau to request state funding for road and drainage needs in the Rabbit Creek Council Area. Several Senators and Representatives were appalled by the photographs of Rabbit Creek roads and questioned why the Municipality, the Assembly, and the permitting process would approve development without the infrastructure to support it. Legislators questioned why our local assembly promotes the higher density development when lack of roads and steep slopes threaten basic public health and safety. Inviting families with children, schools, and seniors into an area without an adequate road system sets up risks from serious vehicle

crashes and injuries to pedestrians and bicyclists. If you live in the RCCC area/ South Goldenview area and are concerned about 650 units of senior housing built at the south end of Goldenview (GV), congestion at the RC/GV intersection and stream erosion/overflow, you should attend the Council meeting May 10. Please send any specific drainage or traffic problems that you know about to Joan Diamond at buddy4@alaska.net.

New Housing Developments Threaten Access to Chugach State Park

A hopeful player—The Great Land Trust (GLT)— has emerged recently in the effort to establish Park access. The GLT is an independent nonpartisan community-based land conservation organization founded by and for Alaskans. The GLT works with willing landowners and other partners to conserve Southcentral Alaska's lands and waterways. The GLT is currently focused on two large Anchorage area

projects: "Pathways to the Chugach," and Little Campbell Creek. Access to the Chugach Park is an important feature that attracts people to live and recreate in the Rabbit Creek area. Access is another form of development that will require partners willing to contribute funding for parking facilities that are compatible with surrounding uses. The involvement of GLT can help preserve some of the more environmentally sensitive areas as well as provide a conduit between the multiple participants.
