### **ARTICLE VI. MEMBERSHIP**

- A. Any person 18 years of age or older is eligible for membership provided that the person is a resident (tenant, resident homeowner or family members) within the Council area. Real property owned by non-residents, business, corporations, and partnerships or for profit and nonprofit organization located within the Council area, each shall be entitled to one voting membership. A member representing such a group must be designated by the parent organization.
- B. A person is a voting member upon fulfilling the requirements set forth in paragraph A and appearing at a scheduled meeting and signing as a registered member;
- C. A person is a registered member immediately after signing the membership-voting register available at every council meeting;
  - a. Membership dues are voluntary and shall be \$5.00 annually. Dues are to be paid at the October meeting or may be paid at any general membership meeting.

### **ARTICLE VIII. VOTING**

- A. Any member of the Bear Valley Community Council as defined in the preceding Articles shall have one vote. Even if a single individual possesses several kinds of property or businesses within the definition for membership qualification, they shall still have just one vote;
- B. In order to be nominated for office, vote for election of officers or on Bylaw amendments, the member, as defined in ARTICLE VI, must have attended two meetings in the six (6) meetings prior to that vote.
- C. Each registered member must be present in person at the time of the vote in order to cast a vote. There will be no proxy voting;
