Fairview Neighborhood Plan

Fairview Neighborhood has been adopted into Title 21 by the Anchorage Assembly. Fairview has been lauded as an exemplary model for neighborhood plans.

SKLEIN - Introduces Resolution and lays it on table. Resolution is celebrating the establishment of the Fairview Neighborhood Plan. SKLEIN asks that the resolution be passed by 2/3 majority, out of normal procedure (laid on table for 30 days minimum before passing a resolution is possible), this one time.

Discussion: DLORING asks if there is a circumstance in place that warrants the council to operate out of normal bylaws. SKLEIN responds that the timeliness of this resolution is the important factor, as it recognizes those who assisted the recent success. DLORING what about the 21 day appeal period for the assembly? They can repeal it and then the resolution has less impact. AKEMPLEN would like to go on record noting that this is out of normal circumstance and should not set precedence.

MOTION: HHEINRICH moves to pass the resolution in hand, LJORGENSEN seconds. 11 For / 2 Opposed. Motion approved. Resolution passes as amended (Resolution 2014-04)

MOTION: SJKLEIN moves to suspend the rules so we can move this resolution now. HHEINRICH seconds. 10 For / 4 Opposed. Motion approved.

SKLEIN seconds. RALLEVA objects. Vote: 15 For / 1 Opposed

RALLEVA comments on his reason for objection. Desires an amendment to the resolution to suspend the permanent fund dividend to allow the state to use that money to prevent the effects of oil on the climate.

MOTION: DLORING moves to reconsider the motion approved. No second. Motion fails.

Discussion regarding Resolution 2014-02 ensues.

CCONSTANT - President's report.

COMMUNITY COMMENTS (15 Min.) Board Members, council members, public AKEMPLEN - 1) The status of the Gateway Arch project? 2) There should be consideration of an adhoc overlay one to move that portion of the Neighborhood Plan forward as an action item.

CCONSTANT - Responds to Gateway Arch. Les and Jonny advise we reappropriate in the next budget and wait until the road project occurs.

AKEMPLEN - Suggests we reappropriate the funds to better the area of the Gateway Arch.

CCONSTANT - Requests that AKEMPLEN drafts a document in support of that idea.

ACTION:: AKEMPLEN to draft supporting document for the reapproriation of funds from Gateway Arch art project on 13th and Gambell to be used for general betterments of 13th and Gambell.

CHODGE - Presents for Shiloh Community Development Church. Events coming up: Food drive, BBQ, and Meet & Greet.

DLORING - When will the appointment be regarding the Brother Francis Shelter MOA? What process and timeline will the Fairview Executive Board develop the Education plan?

CCONSTANT - The appointment is TBD, but upcoming. The education plan is a priority, but no process or timeline is in place yet.

ACTION:: CCONSTANT to set up appointment regarding Bro. Francis Shelter MOA.

RALLEVA - The lot that was of concern to Mr. Alleva was bulldozed but remains a draw for drug use. Requests that the council contact the Mat-Su Valley churches and ask them to stop sending drug users to Anchorage.

CCONSTANT - The method of getting the Fairview Community Council to take action, a motion is the standard method.

MOTION: RALLEVA moves to send a letter to the eight churches in the Mat-Su Valley asking them to not send overflow homeless to Anchorage. DLORING seconds. Discussion ensues, Generalli

MOTION: MOVE to table this discussion until next month by HNEED. AKEMPLEN seconds. Unanimous approval.

ACTION:: Add to new business for next month.

HHEINRICH - Recommends that DLORING could assemble materials in support of his concerns regarding the community patrol group.

MD'AGOSTINO - Brings up the topic of the very bright lights from the street cast bright light onto her property, which is unwanted. Announces that a Alliance for Community Trees in partnership with Boys and Girls Club of Alaska Grant will allow for pruning education and invites youth.

AKEMPLEN - Gives history to the reason for bright lights in general in Fairview, which was purposeful at one point to eliminate shadowed areas.
