On February 15, 2006, there will be a public hearing on the draft environmental assessment for the Echo Parking Phase II Project, as well as a public information meeting on the 2006 construction projects, at the Alaska Department of Transportation and Public Facilities, 4111 Aviation Drive, from 5:30-7:30pm.

LAND USE ISSUES

Chuck Spinelli is appealing an enforcement order involving a coffee cart in an R-O zone at 1900 Northern Lights Blvd. The matter is scheduled before the Zoning Board of Equalization and Appeals on February 9, 2006.

An ordinance amending the sign ordinance to grandfather existing noncompliant signs is scheduled before the Planning and Zoning Commission on February 13 and before the Assembly on February 28, 2006.
