Local Muni Assembly and Anchorage School Board Report

Eric Croft, Tim Steele, Bettye Davis (Bettye Davis not here)

Eric Croft, pond on the budget

Budget just was drafted

\$35M bond for roads and drainage, \$1.4 million for Dimond/Westpark

water drainage system

\$400k first one in 2018, then \$1M to actually build it

6 votes to get it on the ballot as a bond

Croft – resolution through the public safety committee, to make changes to SB 91

SB 54 makes some changes; Croft wants more beyond SB 54

Weirdest political issue Croft has ever seen – good idea but done poorly, implemented bad

Big investment up front, then the savings come at the end – AK didn't do that

Treatment portion sort of coming online, more changes coming in Jan.

2018

Major public work session, Saturday the 7th, 9am-1pm, in the Loussac Library – full public work session

Robert Hall – comment, theft is bad, people getting off the hook, cops getting shot at – this should be mandatory 10 year sentence *Croft* – absolutely, these changes are not good, parole for shooting at cops was eliminated, so criminals could have parole even if they shot at cops

Homeless camps, 15 days is too long to kick them out/clean them up, Croft thinks we can reduce it to 10 days to clean them up – that's another resolution he has

Alan Thornhill – car thefts, slapped on the wrist – not right at all, people losing their transportation and losing their ability to work

Assemblyman Tim Steele

Rampant crime, as a result of SB 91, new system needs to be in place

State doesn't have money to put people in jail

City will be stepping up,

Alan Thornhill – how come Troopers can't patrol a road? Seward Highway issue

Tim Steele – it's what we could do, we had to step up and provide policing

Robert Hall - what happens to people who have stolen a vehicle?

Rep. Grenn – Rep. Claman and I will talk about this

Croft, Claman and Grenn – all chimed in, trying to fix things, related to crime, SB 91 issues

Steele – Muni trying to keep people employed on road projects, Spenard and Turnagain were great projects, but how long can we do this without running out of money?

SLCC Attendee – concerned about accessory dwelling units, this is going to mess up R1 zoning

Alan Thornhill – issues with permitting, takes over 6 months to get a project moving, architect, engineer, too many regulators, *Steele* – well, when doing a project just try to follow the process, *Croft* – it's been this way far too long when it comes to permitting, Republican/Democrat admins haven't been able to deal with it

Legislative Update

Costello's office – staffer, Dakota, giving update Saturday 3:30pm, Tastee Freeze with Senator Costello

Rep. Claman and Rep. Grenn

Claman – 2014, is when criminal justice reform started, Parnell and Republicans began it, longer and longer sentences, recidivism was blowing up, public safety not any better, SB 64 –process began it, very complicated, SB 91 was not the only bill, challenge is great – crime prosecution, 7000 less prosecutions of misdemeanors in the last 3 years, this has nothing to do with SB 91,

Grenn – DOL has loss 23 prosecutors, direct correlation to increase in crime, lots can be cut still in the budget, but public safety we have found the bottom, C class felonies is the biggest concern, SB 54 reverses it and takes us back to before SB 91

SB 91 was a huge bill, 121 pages, some tougher sentences for violent crime, light sentences for non-violent crime, Grenn wants to engage with community, make sure the public is involved and not just government trying to solve the problem,

Cutting the budget, SB 91, fewer prosecutors, opioid epidemic *Robert Hall* - SB 91 made crime pay

Claman – multiple crimes committed by the same person, that person should not be let out, SB 91 didn't make that change, the Legislature is very concerned about violent crime

Claman – super complicated, budget has been cut too deep, issue is the budget, should ask legislators to call on raising revenue, it's not just about public safety, it's about the budget

Rebecca Logan – brought up the point about \$50 million cut from AGDC, to then direct \$5M for prosecutors – did Claman and Grenn vote for this?

Grenn – I sort of voted for this, I added 3 prosecutors into the budget *Claman* – said Rebecca is entitled to that opinion, deflected the question *Kim Hayes* – Rep. Kopp came and talked to us, about treatment and detox, what is being done in SB 54 about this?

Grenn – I follow Kopp on many of these issues, treatment aspect is super important,

Claman – reinvestment in treatment is key, funding is needed for those, Rep. Kopp is taking the lead on this

Alan Thornhill – problem, safety problem, AGDC is a pipe dream, Port of Anchorage as well/Knik Arm Bridge

Grenn – not an either or option, \$100 million that runs out this year, wants to see the gas pipeline progress, giving Governor's office the benefit of the doubt till January next year

Alan Thornhill - we're spending money we don't have on this gas pipeline

Grenn – we need long term economic development, not an either or,Claman – Governor has a high priority on the gas pipeline, Governor has to come and deal with the legislature

Grenn – coffee on Thursday the 5th, at Kaladi Brother 3:30pm, October 19th crime safety meeting at Kincaid Elementary 6pm Grenn – holding special session in Anchorage, very complicated, is generally supportive of it, but it is hard to

Claman – it's not that easy to hold in Anchorage, don't feel the love while we are in Anchorage, conference room is being remodeled, so there isn't space

Terry Lindseth – from the Airport, planning manager

Update on the table Big seaplane base planning is done, Email notices for regulations of the sea base Item #6 has instructions for getting emails about airport planning/runway closures AK Airlines Honor flight, October 10th, returning on October 14th at noon, veterans getting to see memorials, celebration in their return North/South runway is set for reconstruction, big change to flight patterns at the airport

Claire Ross - brought up the issue of appointing officers who have been here/not been here

Alan Thornhill – we need to have people representing us who know

what is going on

Michael – election date, keeping it in January

Robert Hall – how does the election process work/nominating process for officers?

Keeping it in January

3 times not showing up in a row, an officer is kicked out; vote of no confidence officers can be kicked out, more clear language on removal of officer

Claire Ross – any term limits? Michael – not sure of there are term limits, we currently don't have them Alan T. – Spenard has term limits SLCC Attendee – all will be voted on next meeting? Michael – yes, all next month

Tonya Hickock, civil engineer, working with Heritage Land Bank/property/subdivision proposal

3 parcels of land, west of west park, north of Dimond, 54 acres of land Taking 3 parcels, and subdividing the parcels into 2 properties ASD has had money to build out a school, but never had a parcel to build

on

The purpose of the parcel split, is to let the school district to purchase the land, ASD has the bond money

No development plan at this point

Tract 1 will be ASD school, Tract 2 will be sold off for private

development

Claire Ross – brought up Robin Ward, real estate developer, working for Heritage Land bank

Exposed aquifer brought up

Zoning for the area – R1A and some R2A

44 acres, Tract 1 – Middle School and Elementary School Lots of time to comment and weigh in when the development begins to happen, when the site plan actually begins the Community council will have plenty of time to discuss

Muni of Anchorage 2040 Plan Multiple Use Plan Tom Davis, Senior Planner

Tom Davis - Assembly adopted this plan on Tuesday of last week Platting and zoning commission level - tons of work Final version of plan will soon be available for purchase 2040 Anchorage Land Plan Blue print for future growth All about zoning, all about future planning Big goal is to make sure we have enough houses for future and current populations, and future business development Focused on how to deal with infill, re-development of area, Anchorage is landlocked, so lots of smart planning for future Map is a plan, guiding zoning change decisions West Anchorage District plan - we can access this and find out what our plan has in store 1 of 12 district plans, each of these district plans has a lot more detail than the whole citywide plan The city plan binds all the district/neighborhood plans together Plenty of studies regarding future housing needs

Range estimates of future housing needs – up to an additional 50,000 units, population growth – range is between 317,000 to 362,000 people in the Muni

Compact housing, mixed-use city centers – will drive a lot of the growth, midtown/downtown and Spenard

3rd and last section – covers the action plan, what the Muni needs to do with the development community

Work on this plan will begin immediately on the plan, while some will begin 3 years down the road

Re-zoning areas, like Spenard, is key for future growth, Muni would work with Spenard Community Council, big time rezoning of a neighborhood to meet the needs of the Plan

Target area rezoning for South C Street, stop the commercial growth and keep it as a residential area

Jewel Lake Town center – Dimond and Jewel Lake

Need to examine West Anchorage District Plan

Airport District, Tom thinks this will come forward at some point Dimond & Arlene – mixed use residential/commercial mix, R4A zoning was the only tool available, but Muni is working with Developer to change it

Monday October 9th, Mixed-use residential tool zone, Platting & Zoning Committee will be examining it – this is designed for Arlene and Dimond Downtown and Midtown and some U-Med will have the most high density/growth

1000 accessory dwelling units, roughly over the next 20-30 years, is what the Muni is expecting

Within a month or so, the final edited plan will be done and online – according to Muni
