## TUDOR ROAD AND WILSON-CAMBRIDGE INTERSECTION

As reported in the July 25, 2004 Anchorage Daily News (ADN), a motorcyclist traveling east on Tudor Road was killed the Sunday before when he was hit by a car turning on to Tudor from Wilson. As the article points out, there were 14 accidents at this intersection in 2003 and a traffic light has been considered in the past. The matter of how to improve that intersection was discussed at the August meeting. Scott Thomas, the Central Region Traffic Engineer for the Department of Transportation, will answer questions at the September meeting about alternatives for this intersection.

## POSSIBLE SKATING RINK AT POP CARR PARK

Steve Hennessey brought up the possibility of installing a skating rink at Pop Carr Park at the June meeting. Since it was not on the agenda, no action was taken. The matter was discussed briefly at the August meeting and will be discussed again at the September meeting.

### NORTHWOOD PARK IMPROVEMENTS

### PENDING ZONING MATTERS

- 1) Deloris Dash and James and Joyce Paulus seek to subdivide four parcels in the Woodland Park Subdivision (Lots 10E-1, the south 5' of 11E-1, 12E-1, and 13D) into two lots with vacation of the south 50 feet of Willow Street. The matter will go before the Platting Board on October 6, 2004.
- 2) Arvin Miller seeks an administrative variance to allow a house on 3600 Oregon Drive to encroach into the required setback. The matter will go before the Planning and

Zoning Commission on September 3, 2004.
