- 5) Speaker Topic Jack Gadamus (Municipal assessor) Municipal Property Value Assessment, new website, and property portal
 - a. Introduced the new tools for assessing property info through www.Muni.org
 - b. Residential value changes for this year increased an average of 1.2-3.7%. Higher increases in value in South Anchorage (District 6) vs other Districts.
 - c. Drive behind increased property assessments includes:
 - 1. Reduced supply due to low inventory and limited new construction
 - 2. Reduced purchasing power due to high inflation and increasing interest rates
 - 3. Increased price of substitutes due to increased rent prices and decreased vacancy
 - d. Exemption options for homeowners are available
 - 1. State (up to \$150k of valuation) for disabled veterans and senior citizens
 - 2. Optional (20% up to \$50k) for owner-occupied residential property
 - 3. Have to file for exemptions by 3/15/23
 - e. Valuation Notices for 2023
 - 1. Were green last year, this year they are white cards with a green stripe

- 2. School bond will be on April Ballot, includes redoing entry vestibules at elementary schools so there is only one point of entry from the outside with inner and outer doors
- 3. If ASD closes schools, then state does not give as much money. We have 65 elementary schools and the students we have could all fit into 50.
- 4. To make-up for all the snow days, school days are being extended by 30 minutes each day from 1/30-3/9 and with full instructional days on 2/22, 2/23 and 2/24.
- 5. Gretchen asks about Inlet view- no discussion as of yet.
- 6. ASD planning on closing Abbott Loop, no others at this time.

- a. Lake Otis to be repaved between Huffman and Abbott in 2 phases
- b. Phase 1- fall 2023 Huffman to O'Malley
- c. Phase 2- summer 2024 O'Malley to Abbott
- d. There is discussion regarding keeping the 4 lanes vs changing to 3 lanes (1 lane each North and South with a suicide lane)- per Brad has been shown to reduce crashes by 25-50%, looking for a resolution for supporting 3 lanes

 - a. Treasurer's Report- T Lovdahl- Current balance is \$917.34. We received notice that starting 2/1 our current bank is going to charge \$5/month every month we have less than \$2500 in our account. They do not waive fees for non-profits. Gretchen agrees that we should research moving our money into an account that doesn't require such a high minimum. Trina will write a check back to HALO for \$400 so they can request more info for property assessments and \$75 to HALO for the candidate forum. Trina will reimburse John Yeafoli for the microphones he purchased for HOCC meetings when we receive a receipt.

Discussed removal of vegetation and upkeep as trees, willows grow. Spruce and birch in suburban areas are not as healthy as a full undisturbed forest. Tim and his wife presented their case. Unaimous approval to support the change with no concerns noted at meeting.

Note Added in February after meeting. Email submitted to Platting Board by Gretchen Stoddard as Chair of HOCC:

"Huffman O'Malley Community Council has no objection to the change proposed by Platting Board Case S 12708 related to vegetation and access at Donalds Street. HOCC supports and encourages the change to improve access to this problem, and we believe this might go a small part towards improving access to the area during a fire emergency. Requiring trees to remain at the edge of the road as they grow larger does not improve access to the area during a fire and may make the current problems with this narrow muni maintained road worse. "
