1. U-Med Destination Plan -

John Cecil, Municipal Planner

This study is sponsored by AMATS. It is a demand management study. Has an interactive website.

2. Title 21 Updates -

Ryan Yelle, Municipal Planner

Main purpose is to eliminate clerical errors and to create a process that is easier for builders. Section I includes a timeline for community meetings. One change in the FINAL DRAFT is the modification process for alcohol permitting. The ordinance goes to the Anchorage Planning & Zoning Commission on April 10, 2023.

 Anchorage Parks Items on April 2023 Municipal Election Ballot -Beth Nordlund, Executive Director, Anchorage Parks Foundation There is a Parks bond is on the ballot that includes projects all across the Municipality.

There is also a second parks related item on the ballot this April – a vote on whether or not to create a "Chugach State Park Service Area" that could (in the future) be used to fund improvements on Municipal lands that assist people in using Chugach State Park. There is not a bond this year for the proposed service area.

Requesting monies from the State government. It is especially important that we are able to get the "Match" funds for funds we acquire from other sources to pay for parks improvements.

We have a very informational Assembly Newsletter that you can sign up to receive. Next regular meeting is Tuesday February 21st. There will be public hearings on ordinances about an "Open Checkbook" that shows all Municipal expenses and on proposed changes to Municipal holidays. Other topics include a ground lease for the Anchorage Police Department (APD) headquarters in downtown, and on temporary snow storage sites. A parental leave policy for 160 hours of leave is being introduced with the public hearing set for March 7th. It is hoped that this will help attract more workers. Staffing is a big issue in the Municipality

The Municipal elections are scheduled for Tuesday April 4th! There are seven

Assembly seats up for election this time as well as two School Board seats. And a BUNCH of bonds and resolutions. Check the Municipal website for information on the election. Overseas ballots will be mailed out soon, with the rest of the ballots in the mail on March 13th. This is a vote-by-mail election. You can sign up for ballot tracking.

3. Anchorage School Board (ASD) -

Margo Bellamy, Board President

Next meeting is Tuesday February 21st. Preliminary budget includes one-time funds from the State and Federal governments and from our savings account. Alaska Literacy Law. Snow day makeup. Working hard to advocate for the State Legislature increasing the Base Student Allocation (BSA) which gives us funds for each child enrolled in the District. The Spring Lottery is soon for those parents wishing to enroll their children in certain schools. The bond on the Municipal ballot this year is for \$37.8 million and is entirely for maintenance and upgrades to existing schools. The 2024 bond should include funds for Inlet View Elementary School.

If he finds that it does follow the ordinance, he will submit it to the Assembly for their approval. Your revised bylaws do not take effect until the Assembly has approved the revision. We will post the Approved bylaw revisions after the Assembly has approved them. We will post DRAFT revisions if you would like, but we will show that they are DRAFT.
