# Representatives' Reports

AK Senator Kelly Merrick (recorded from Juneau)

- Three weeks into session. Enjoying new position as senator representing Chugiak and Eagle River.
- Member of Finance, State Affairs, Joint Armed Services and Labor & Commerce Committees,
- Chairing budget subcommittees: Dept of Revenue, Dept of Environmental Conversation, Dept of Military & Veterans Affairs
- Just starting to hear legislation; focus now is on Governor's FY24 budget.
- Send capital budget priorities by February 14. Limited funding but may try to get some smaller projects approved. Working w/Rep. Allard and Rep. Saddler to prioritize. Trying to get Sterner Bridge approved again after veto.
- Town Hall w/Rep. Saddler on February 17, 5:30-7:00pm, Chugiak Senior Center

### **Assembly Report – Kevin Cross**

- Confirmed bond proposals for April election. Matching amount bonded to amount retired except Parks & Rec bond is larger than amount being retired; try to keep property taxes same.
- Purchasing Dept. was 'working around' Assembly approval process. Undergoing very time-consuming audit.
- Community & Economic Development Committee Vice-Chair-Working with state on marijuana, a controlled substance, while hemp is controlled through Agriculture Dept with less regulation. Manufacturers have developed synthetic derivatives that are intoxicating, and market has developed selling hemp products through stores to minors in AK. Working with state, federal agencies & marijuana industry to stop sales and close loopholes.
- Muni. relationship with AK Dept of Transportation has improved significantly with monthly meetings being conducted to prioritize work.
- Chugiak-Eagle River Parks & Rec has new director, Tanya Lieberman. Chugiak Pool repairs are highest priority. Questions:
- Artillery Rd. DoT project DoT is considering re-prioritizing due to multiple accidents; traffic congestion.
- Girdwood Housing Resolution Too much Girdwood opposition so Assembly has tabled this indefinitely. Heritage Land Bank is working with Girdwood to create a Girdwood Housing Board to address issues.
- Municipal Board appointments haven't been kept up to date. Approved 60-day extension on current members.

#### School Board Report – Carl Jacobs

- \$68M budget deficit reduced by \$25M but still issue due to funding at 2016 level.
- Policy revision to student nutrition and physical activity. Guarantee 20 min. for lunch from time student receives meal. Updated recess and physical ed. practices to federal recommended levels.
- School choice lottery is open for applicants until February 15. See ASDK12.org website.
- School bond in April is focused on school safety (e.g., entryways)

Question: Is adding 6th grade to middle schools under consideration? Yes, for some schools.

#### **New Business:**

Community Wildfire Egress Project - Art Skoog/ Julie Jessen (Institute for Social and Economic Research)

- Goal to update community wildfire protection plan.
- Michelle Torres is coordinating training for Community Emergency Response Teams (responding to variety of emergency response needs).

- Community Wildfire Prevention Plan in Eagle River is very outdated. Also have other topics to investigate:
  - Ask fire dept for priority projects.
  - Have FD trucks drive our roads to be sure they can maneuver in all neighborhoods.
  - Establish an evacuation area.
  - Can't apply for grants to fund activities without accurate, up-to-date plan.
- Sign up at end of meeting to participate in an ad hoc committee on this topic within our council.

#### **Community Emergency Response Team (CERT)**

- CERT is nationally supported (FEMA), locally implemented initiative that teaches people how to better prepare
  themselves for hazards that may affect their communities. CERT trains the public in basic disaster response skills
  such as team organization, disaster medical operations, fire safety, light search and rescue, disaster psychology,
  freeing professional responders to focus their efforts on more complex, essential, and critical tasks.
- Have trained members in community to help your neighbors in emergency.
- Need CERT team Lead, sponsoring agency (e.g. fire dept, police team, community council, etc.) & 20-hr training.
- Willow helped set up shelter prior to Red Cross arrival, runners during fire w/FD, vaccine clinics, traffic control.
- Kevin Cross: Anchorage Office of Emergency Mgmt to setting up Emerg. Mgmt. Task Force to provide CERT training.

- Entire 104 acres must be included in plan due to it being a single parcel. At this time, nine (9) lots are planned on north side of Eagle River Rd (drawings displayed). No other development is planned at this time per Eklutna representative (owner).
- Lots will be minimum 1 acre each with well & septic; probably one road with cul-de-sac; R6 zoning.
- Lots will be offered for sale.

# Questions included:

- Will school bus turn-around be changed? Probably not since it is part of an access easement.
- Further development on north? No plans to develop Tracts A & B on north. Zoned R6 and R10. Would be very
  expensive and difficult to develop due to zoning change requirement and need to develop roads and
  infrastructure.
- Access? Eagle River Rd. is a state road so DoT typically denies requests for driveway access.
- Timing? If ready to present to Platting Board by June, will conduct soil tests for septic and possibly offer lots for sale by fall, 2023.
- Write to Anchorage Planning Department if you feel a conservation easement is needed.
- Please provide an update on this project at the May 10 ERVCC meeting.
