Minutes

Welcome/Call to Order

- President Meg Mielke called the meeting to order at 7:08pm
- Consent Agenda (Minutes from previous meeting 06/07/2023, Agenda for current meeting)
 - Margaret McDonagh moved to approve the consent agenda; seconded by Jed Smith. No objection, consent agenda approved.
- Mielke introduced the executive board and announced the incorrect agenda for the meeting had been printed, but the correct agenda is available online.

Brief reports (10 mins each)

- School Board Report: Dave Donley
 - Not making proposals for school closures
 - Massive deficit for next year \$60mil
- Assembly Report: Felix Rivera
 - Body worn cameras APD looking to have 30 body worn cameras on officers as volunteer program, hoping for full implementation in 2024. Wants APD to have a public timetable
 - MOA Trust fund Board will take over responsibilities of single MOA employee to a board of 9 individuals - will vote on board members at Sept 12 meeting
 - Homelessness Tudor and Elmore navigation center was was voted down by Assembly for a few reasons:
 - Cost, both capital and operating
 - Fire safety
 - Size of facility
 - Currently focused on emergency cold weather shelter; looking at non-congregate spaces such as hotels
 - Get better results from hotels
 - Better for residents than a large congregate space
 - Small increase at covenant house for transitional age youth 18-24
 - If not enough hotel space, prepare for population that might not fit hotel space for various reasons
 - AHD trying to figure out where to put small congregate space
 - Funding for plan on 9/12
 - Operation/implementation later in September
 - Assembly appropriated 220K to help mitigate large encampments

Decision topic: Resolution 2023-5: A Resolution Opposing Lease from Alaska Railroad Corporation
