A RESOLUTION IN SUPPORT OF REVISING THE RESIDENTIAL PLOW-OUT PLAN

WHEREAS, [something about how although more resources would be great, in the interim you have to make better use of what you have];

WHEREAS, ~~residential and business~~ mobility for all residents after a significant snow event is key to quickly returning the Municipality to full function;

WHEREAS, the Anchorage Municipality already recognizes the value of preferential plowing of select roads and streets (e.g., main roads and arterial/collector streets) due to their impact on large numbers of residents and businesses;

WHEREAS, the current residential plow-out plan treats all residential roads equally, making no distinction among the numbers of residents served per distance unit of plowing;

WHEREAS, prioritizing plowing among the non-main roads and non-arterial/collector streets based on resident density would more efficiently utilize the limited plowing resources available to most quickly return the Municipality to full function;

WHEREAS, the current residential plow-out plan assumes all residents are equally harmed by the snow event and benefitted by the plow-out, acknowledging no differential impacts;

WHEREAS, not being plowed out is more likely to more heavily impact lower income residents through lower access to remote work options, lower likelihood of owning a vehicle able to handle snow well due to their higher costs (e.g., those with 4WD, studded tires, high clearance), and a smaller economic cushion when faced with missed income from missing in-person work;

WHEREAS, prioritizing plowing among the non-main roads and non-arterial/collector streets based on resident economic rankings would address the disproportionate impact of a plow-out across different neighborhoods;

NOW, THEREFORE, BE IT RESOLVED, that the Airport Heights Community Council supports an updated snow plow-out plan that equally balances residential density per road mile and average income as reported by Census data to prioritize residential plowing after the main roads and arterial/collector streets are finished; and

BE IT ALSO RESOLVED, that based on those criteria, the Airport Heights Community Council proposes a residential plow-out prioritization as shown in Figure 1 [Jena - make a map].
