BROWN JUG CONDITIONAL USE PERMIT APPLICATION

Brown Jug has recently applied for a conditional use permit for a package store at 2710 Spenard Road (the former Space Station building near Spenard Road and Northern Lights) to replace their existing store at 2534 Spenard Road (next to the La Mex), which will be closed. The former Williams gas station property at Spenard and Northern Lights will be used for parking at the new store. The Council discussed and voted to approve the application at the August meeting. The matter will go before the Assembly on September 27, 2005.

TITLE 21 LAND USE CODE MEETINGS
