#### **ZONING UPDATE**

Ersin Aygun's petition to rezone Tract 2 of Boettcher Subdivision (next to Gwennies on Spenard Road) from R-3SL to B-3, which was opposed by the Spenard Community Council and which was previously rejected by the Planning and Zoning Commission, was approved by the Assembly on November 22, 2005. Because of this decision, the 10 acre residentially zoned parcel on Tract 3 no longer has access to Spenard Road; if Tract 3 is developed, its only access will be on Northwood Drive. This matter will be discussed at the December meeting.

## LIQUOR LICENSE ISSUES

Istanbul Cafe, located at 640 W. 36th Avenue (in the Midtown Community Council area) is applying for a conditional use to permit a restaurant liquor license, which will go before the Assembly on December 13, 2005.
