### **LOCATION OF ADDITIONAL SECURITY CAMERA**

In 2013, through a Westside Community Patrol Grant, the Council was able to place a security camera at Blaine's Art Supply and at Tommy's Burger Stop, to monitor activity in the area of Benson Boulevard and Spenard Road. A third camera was purchased with the grant, although it has never been installed. The Council will discuss the location of the third camera at the January meeting.
